MEMORANDUM OF ASSOCIATION

OF

- 1. The name of the Company is WANSA GENERAL METAL CRAFTS LIMITED.
2. The registered office of the company shall be situated in the Republic of Uganda.
3. The objectives for which the company is registered are:-
a) To carry on the business of manufacturing, producing and designing furnishings, frames, doors, decorations and of dealers of the same and all kinds.
b) To carry on the business of exhibitors, manufacturers and dealers in art works, makers and sellers of metallic frames and other instruments and ingredients relating to such business.
c) To carry on the business of glass blowers and manufacturers, embossers, engravers, lead workers and show case manufacturers and producers of other articles made of or incorporating glass in sheet of fabricated form.
d) To carry on business of interior and exterior designers of offices, homes, schools and any other such premises.
e) To provide public or private entertainments, services and facilities on any property of the company
f) To establish or acquire and carry on offices, trading stations, factories stores and depots, general warehouse for different purposes of trade and to purchase, lease or otherwise acquire, develop and improve any business.
g) To carry on by wholesale or retail or be interested in the business of procurement and importation, exportation of all types of merchandise goods,

material and commodities and other goods of whatever description in Uganda and other countries.

- h) To carry on business as general transporters, carriers of goods and passengers either by road, air or sea storage contractors and warehouseman shipping clearing and forwarding agents, travel agents, garage, proprietor motor spare dealers, hotels, bars and catering contractors.
- i) To own, hold, buy, market, trade or otherwise deal in equipment, utilities, machinery, utensils, gadgets and anything deemed to be proper for effective carrying out of the objects of the company.
- j) To import, act as manufacturers agents, and or deal in all kinds of computer hardware, software and peripherals, plant, equipment machinery and all types of tractors, trucks, heavy duty vehicles and accessories and appliances generally used by civil engineers in construction and building works.
- k) To enter into, take over, negotiate or otherwise acquire any contract or contracts for the construction, building, equipping, fitting out, storing, gearing or otherwise relating to any steamship, ship trawl, catcher, carrier, drifter, fishing boat, boat, or vessels whatsoever, and to enter into take over, negotiate or otherwise acquire any such contract or contract such prices and for considerations, and upon terms and conditions, and subject to such stipulation and agreements as the company may determine, from time to time vary, modify, alter, cancel any such contract.

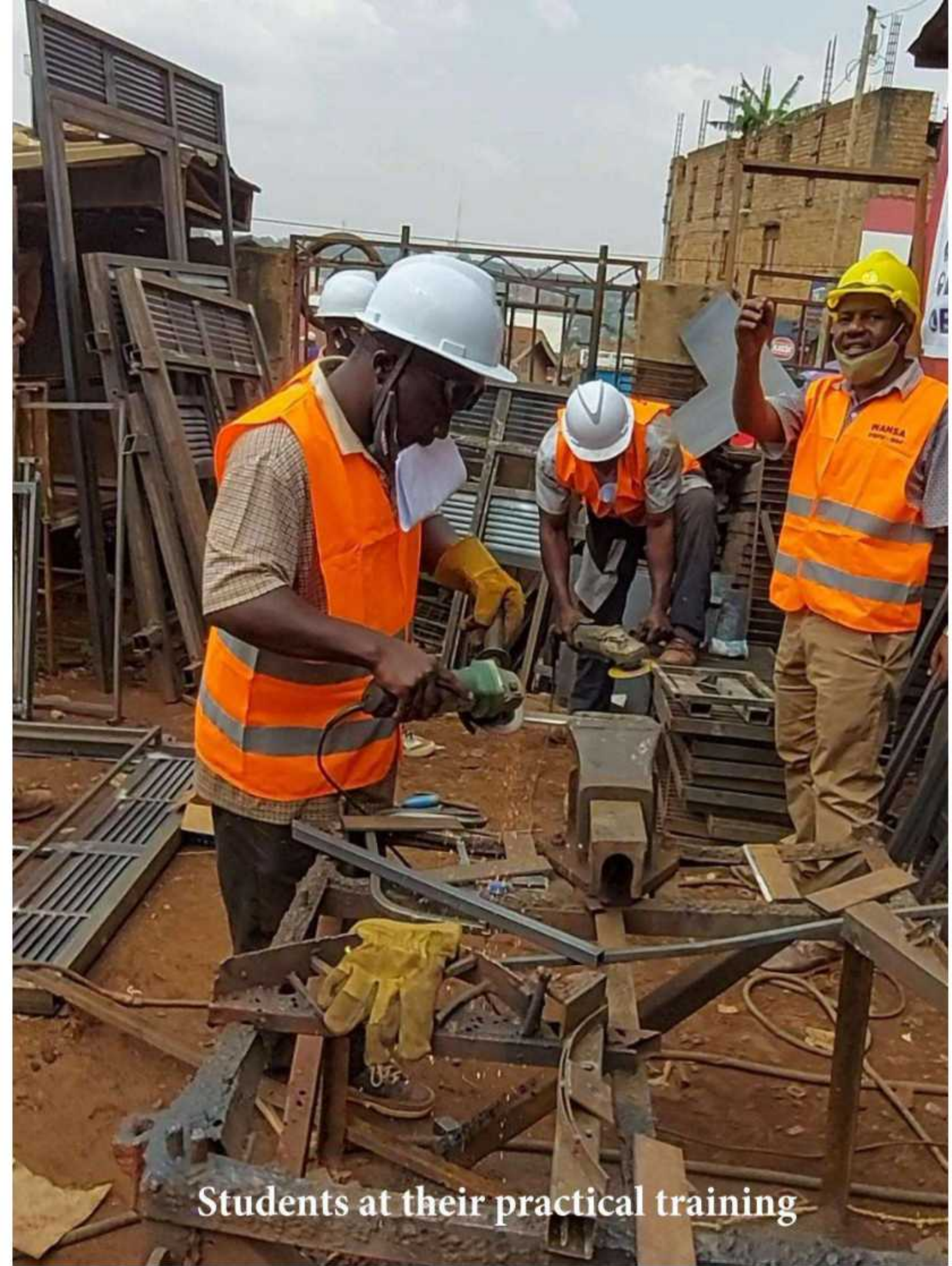

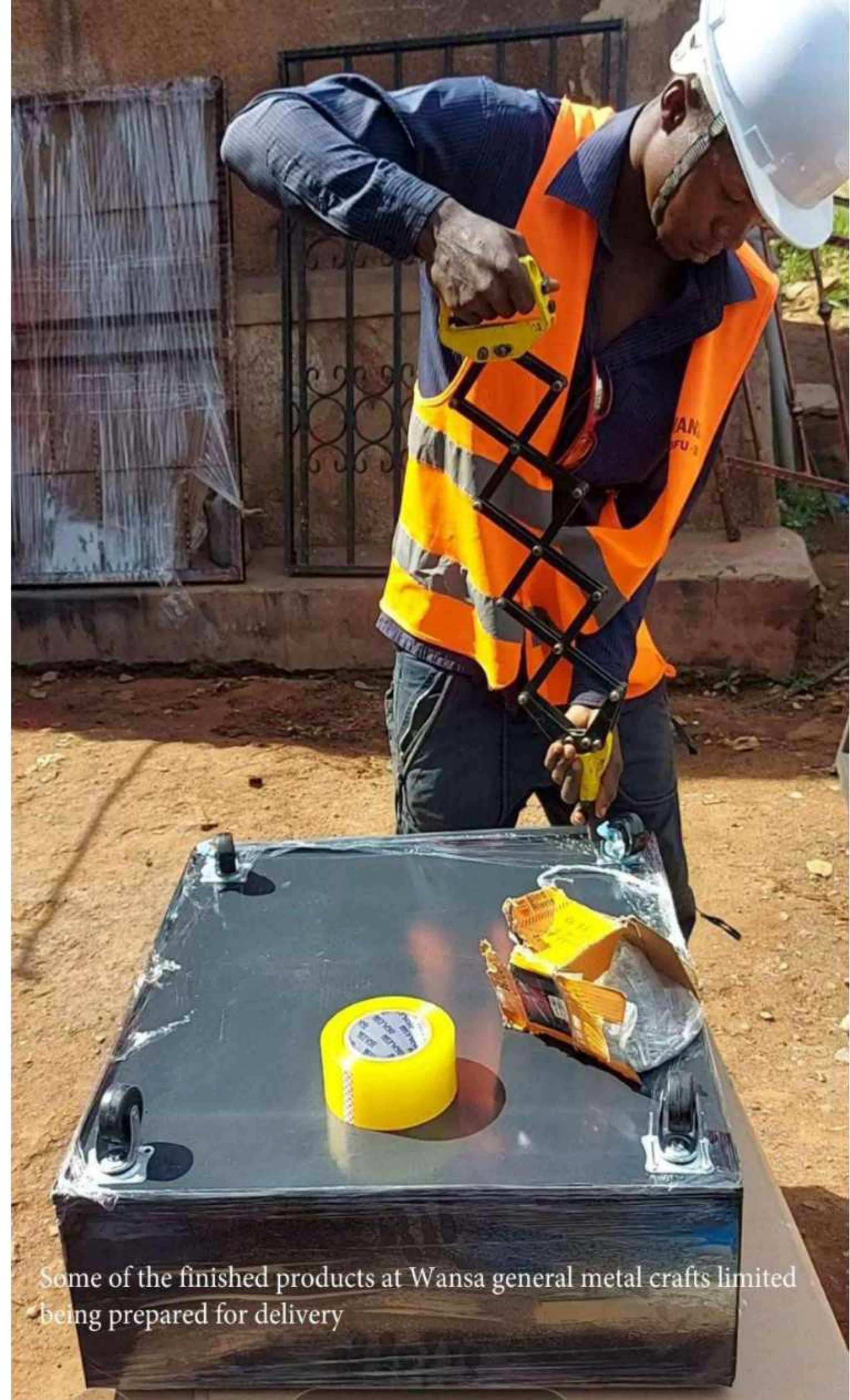

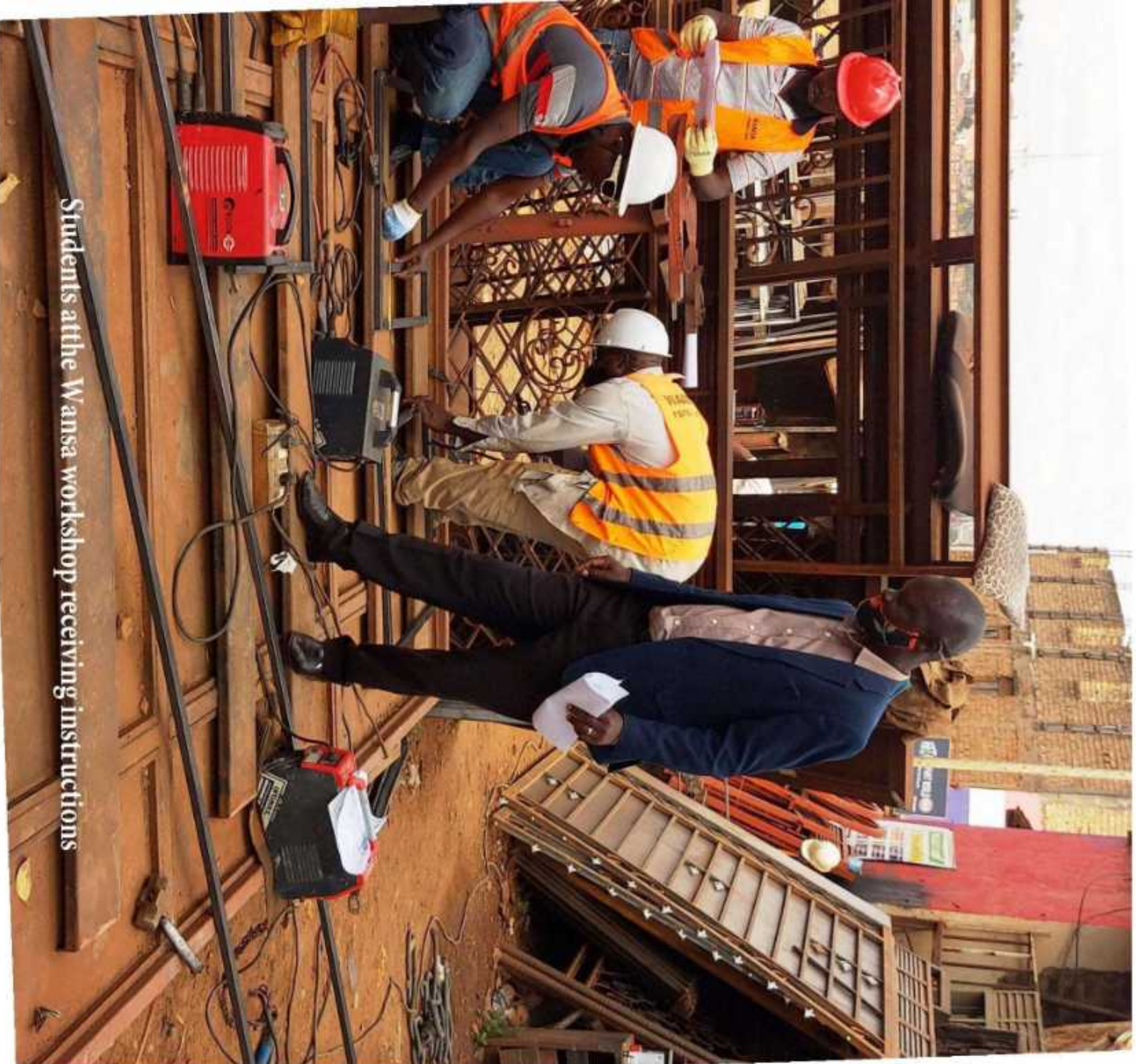

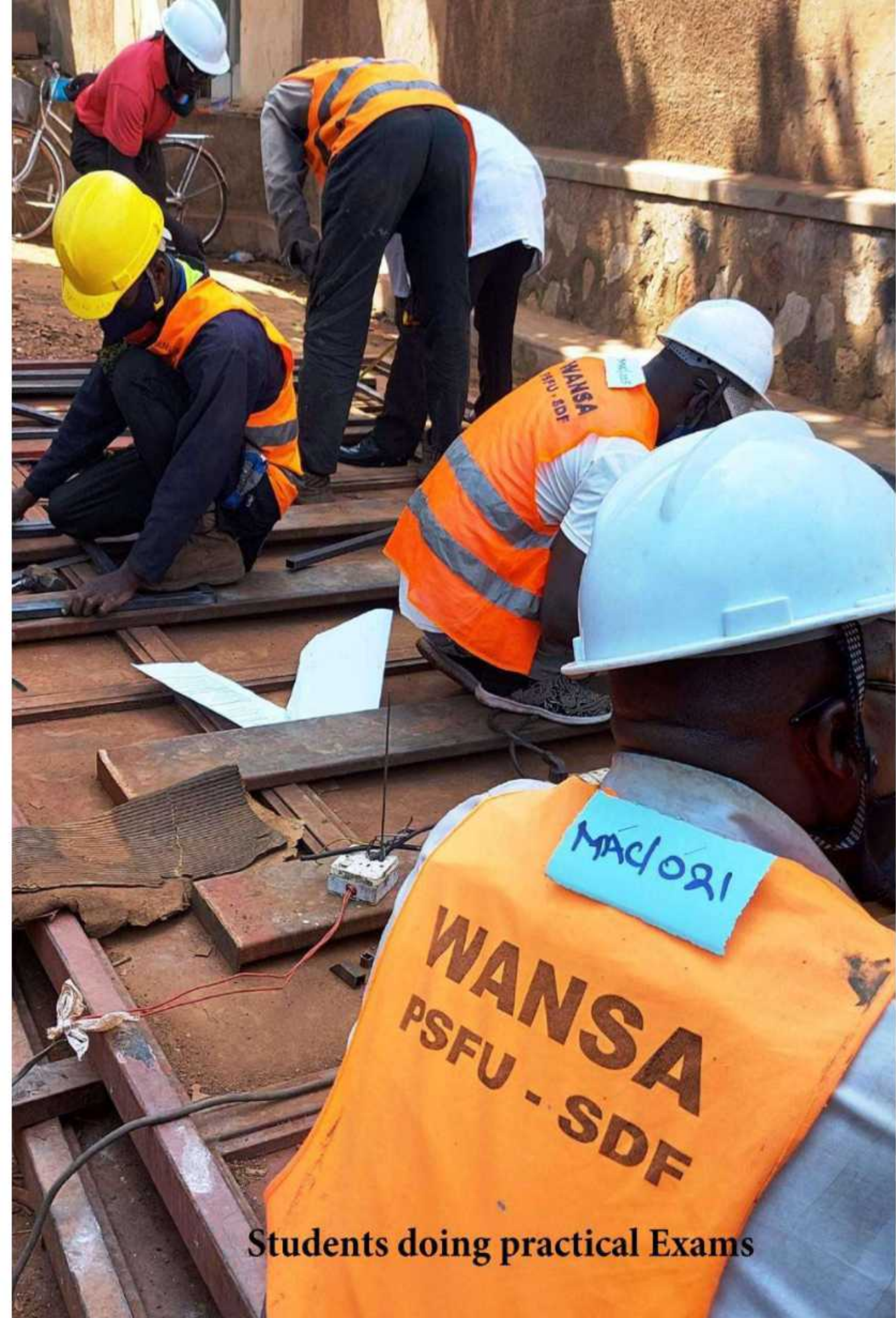

**THE PARTIES HERETO AGREE AS FOLLOWS:**

**I. Consideration**

- (a) For the consideration hereinafter mentioned the Contractor will upon and subject to the Conditions annexed hereto carry out and complete the Works shown upon and described by or referred to in the Contract Bills and in the said Conditions.

After receiving the certificate, the Supervisor shall decide whether or not to accept the works. If he has any reservations, he may pronounce the works accepted with reservations and shall notify the Contractor of his decision, giving the Contractor a specific time frame within which to execute or complete works omitted or only partially completed and to remedy any defects and faults that may have been discovered. Once the stated period elapses, the Client shall have the right to have the works mentioned in the provisional acceptance certificate carried out by a firm of its choice at the expense and risk of the Contractor

**Article 22: Defects liability period and final acceptance**

The defects liability period shall run for two (2) months from the date of provisional acceptance. During that period, the Contractor shall be formally placed on notice by the Client to execute the works required under guarantee. In the event of refusal or non-compliance, the Client shall be automatically entitled to execute the work still to be done and to withhold from the Contractor's Retention money all sums necessary for reimbursement of the expenses incurred. Final acceptance shall be declared at the end of the defects' liability period in the form of an official report sent to the Contractor.

**Article 23. Materials for works**

All materials for the works shall be procured by the contractor and are expected to be of acceptable quality by the client and supervisor.

## CHAPTER III- FINANCIAL PROVISIONS

### Article 24: Contract price

- Refuses or neglects to provide the full list of personnel, works programs, and the list of its equipment of the quality required for the execution of the works.
- Neglects to pay its Subcontractors, Suppliers or personnel (IF ANY).
- Continually fails to comply with the laws, regulations or with the instructions given by the supervisor;

- Violates the provisions of the contract in any other way

The client shall notify the Contractor in writing when these events occur. The written notification from the Client shall enjoin the Contractor to correct the defect within five working days following the date of receipt of written notification. If the Contractor fails to correct the defect the Client may without prejudice to any other remedy to which it may be entitled cancel the contract.

**Article 33: Compensation to Contractors Personnel**

**Article 35: Inclement weather**

Under no circumstance may the Contractor seek compensation for disruption or delays caused by rain or other inclement weather conditions except major flooding

**Article 36: Liability**

The Contractor shall be liable during execution of the works for all damage, harm or accidents of whatever nature to third parties caused by its personnel or equipment or resulting from the works.

**Article 37: Protection of buildings and infrastructure.**

The Contractor shall take all measures necessary to protect buildings infrastructure and their surrounding areas. In particular he shall ensure that the structure and equipment are not damaged. In the event of damage
